NEW, FIRST YEAR IN COLLEGE STUDENT APPLICANTS

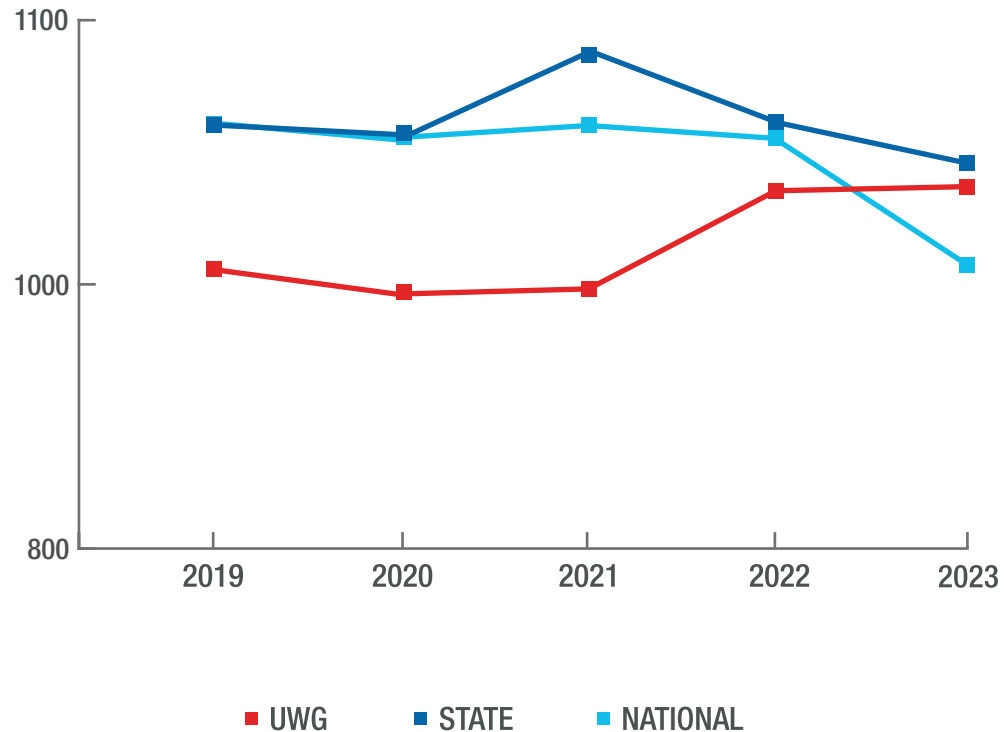

MEAN SAT COMPOSITE SCORE (EBRW + MATH)

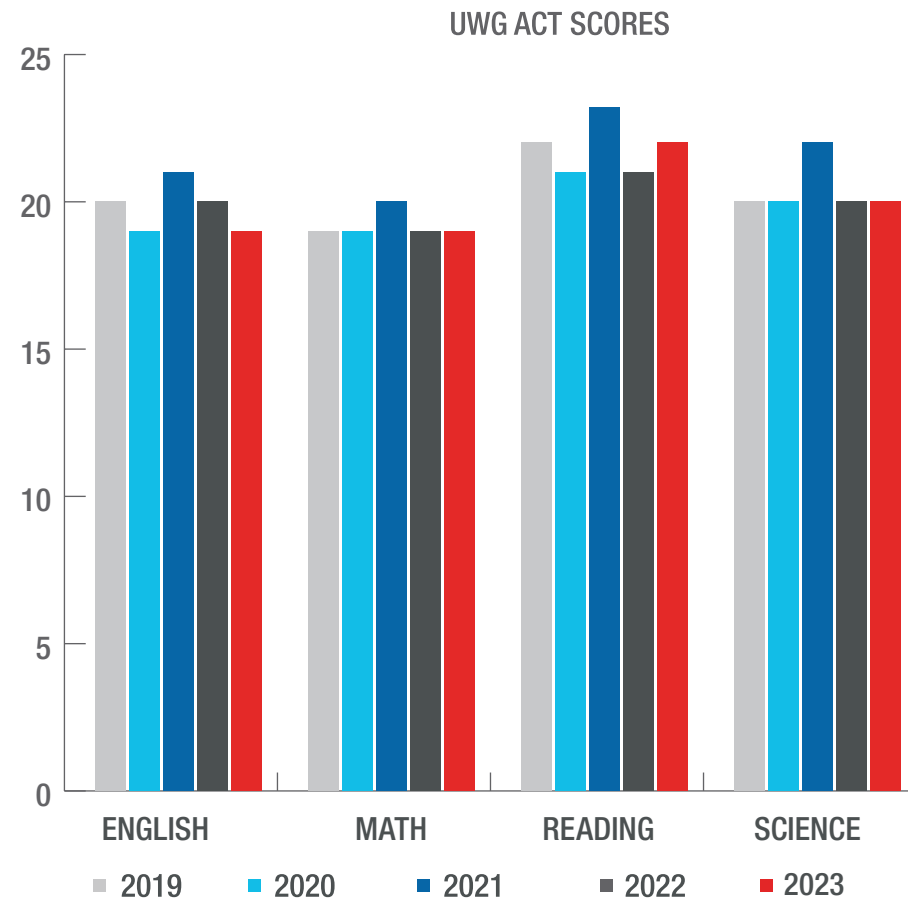

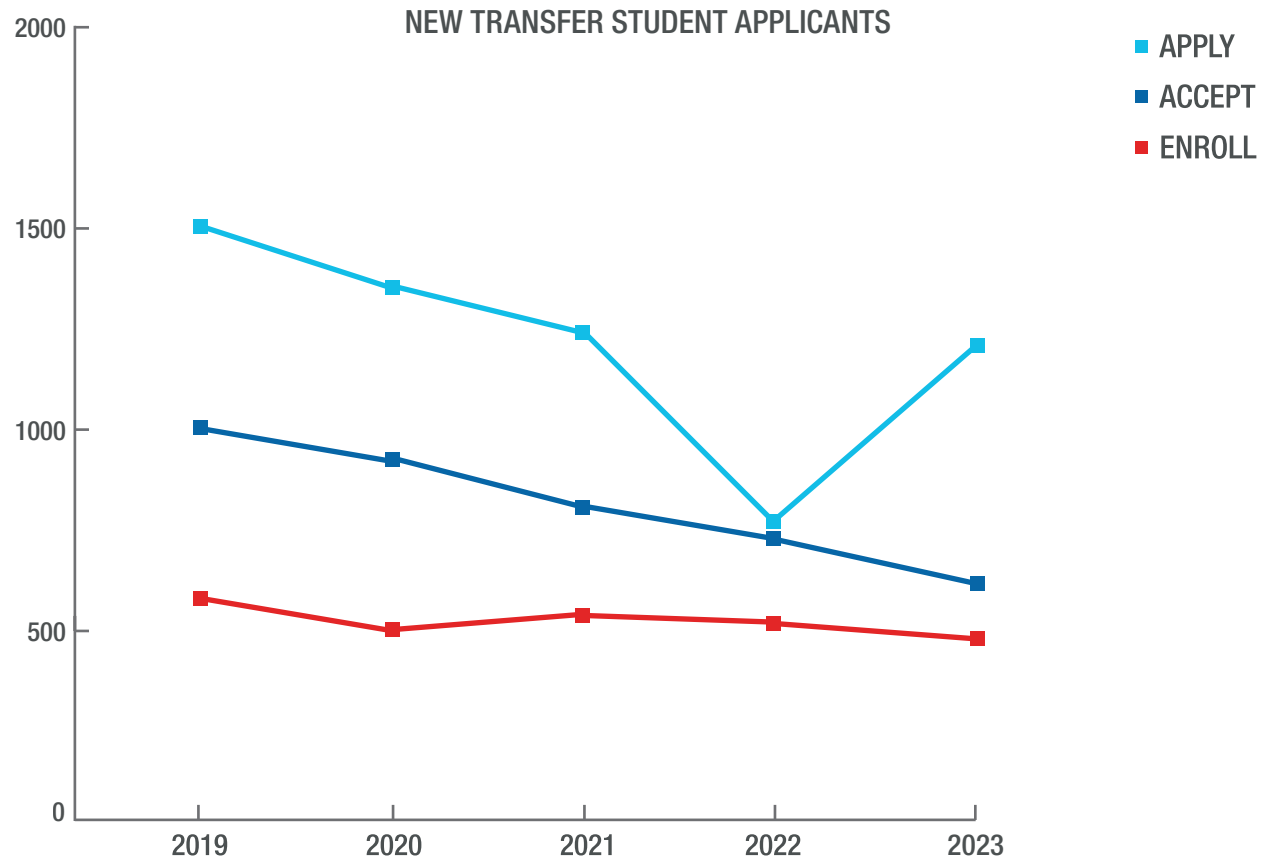

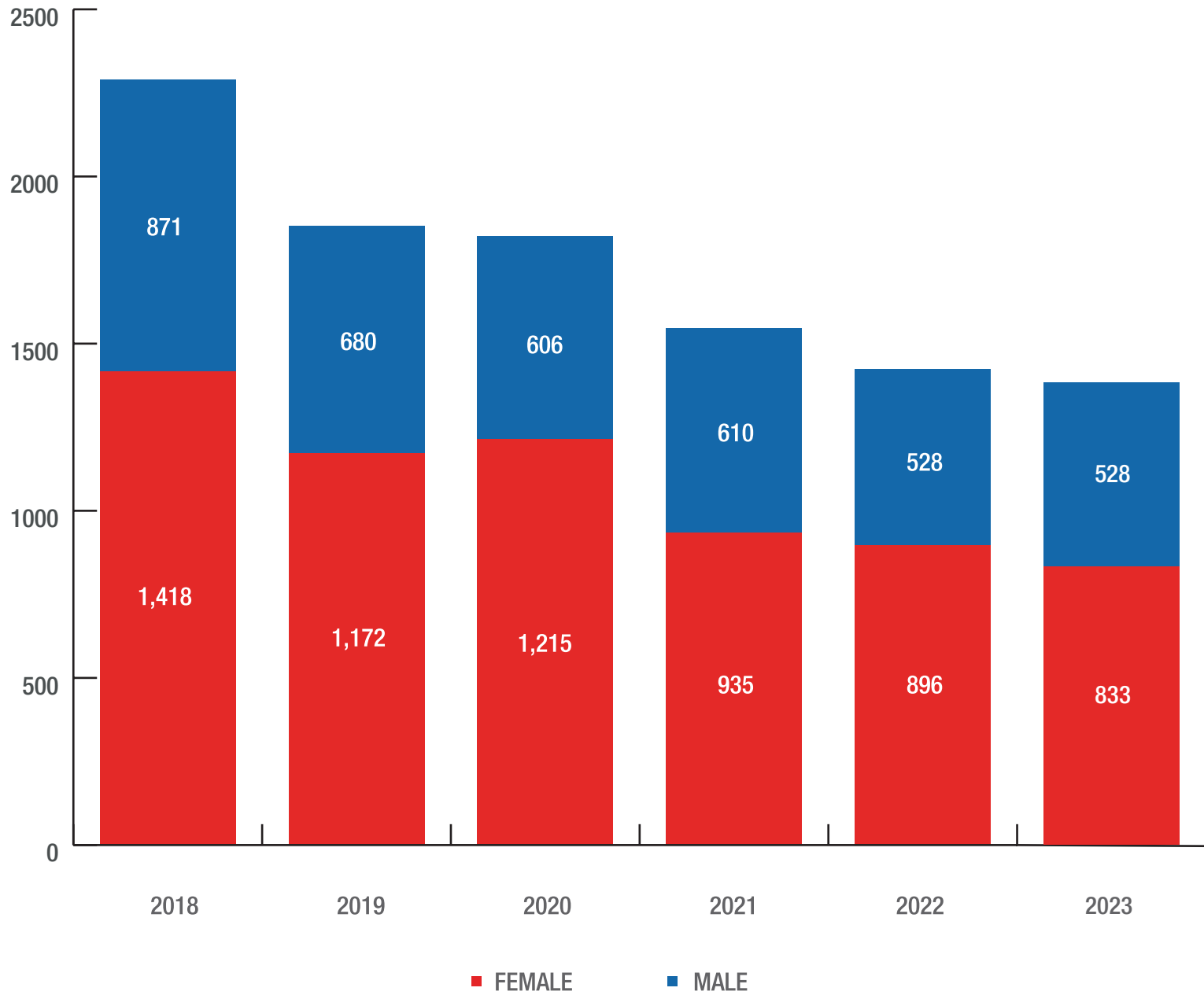

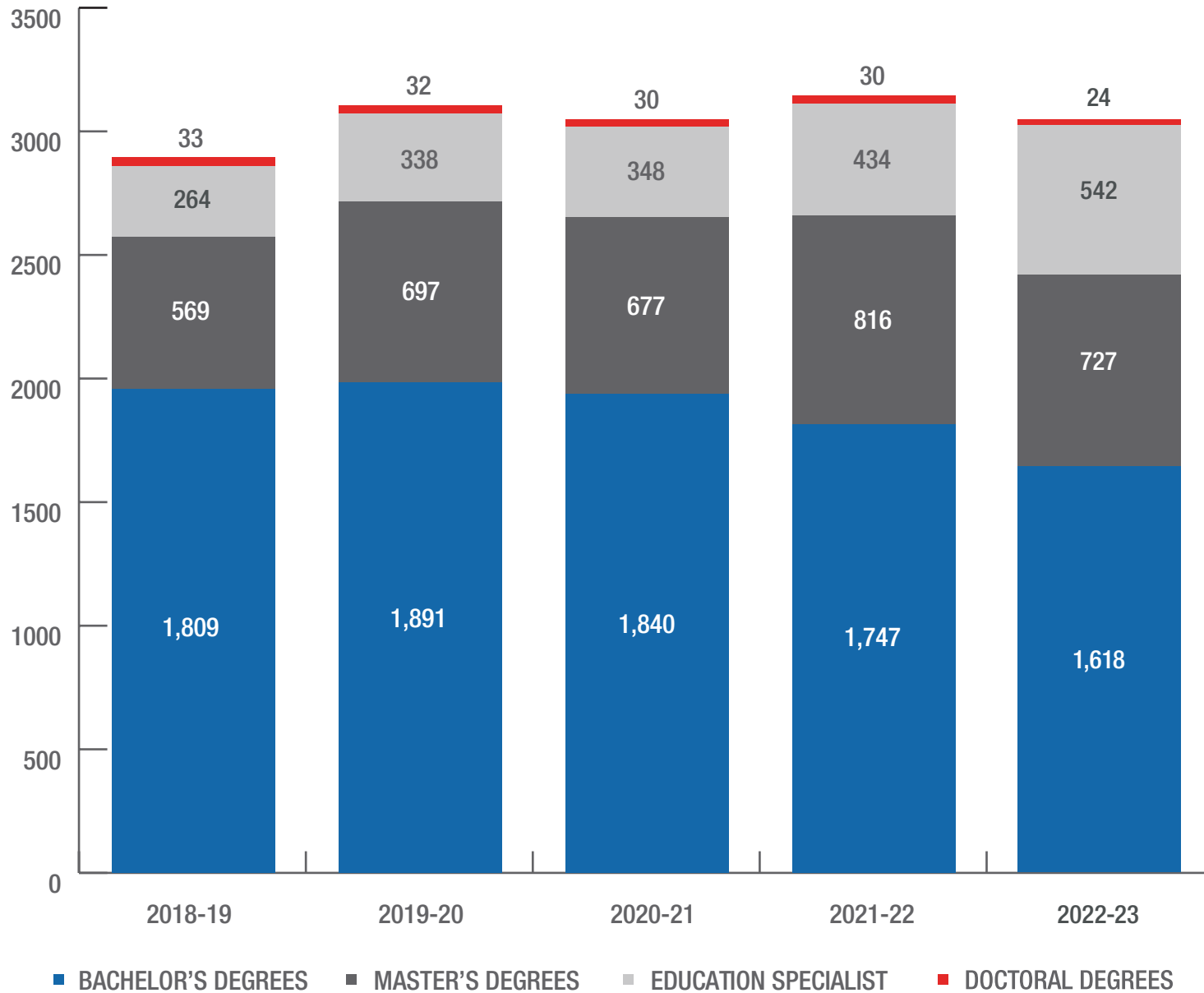

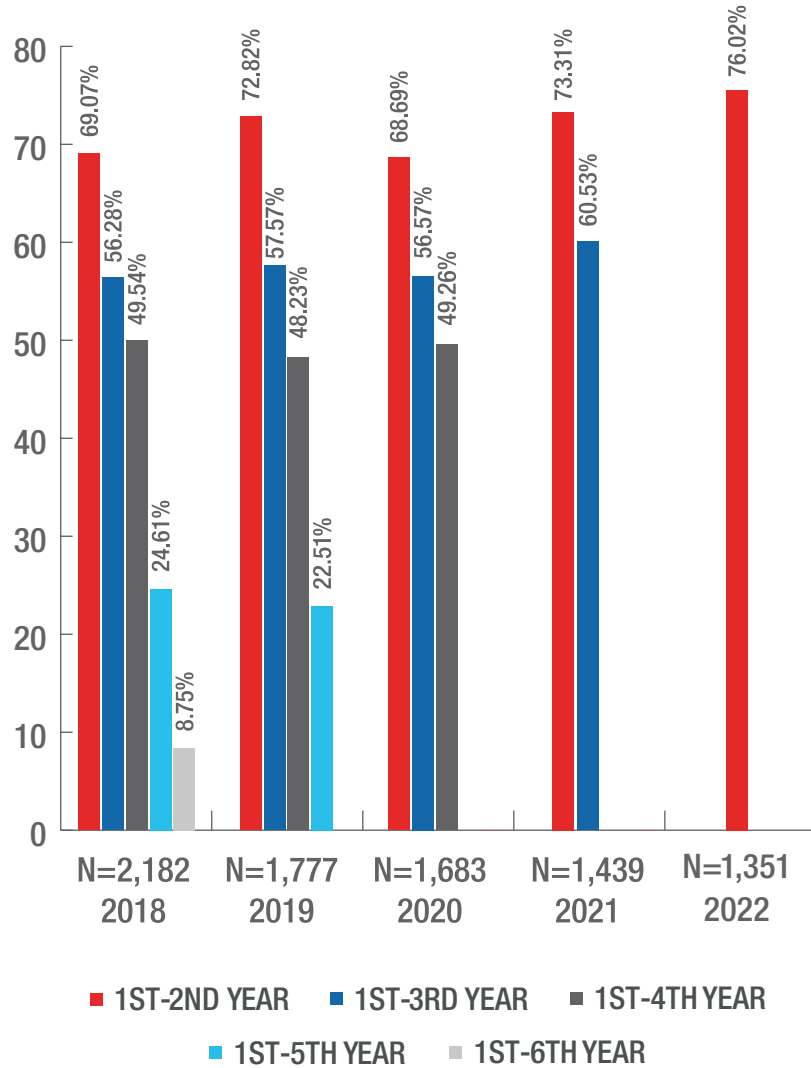

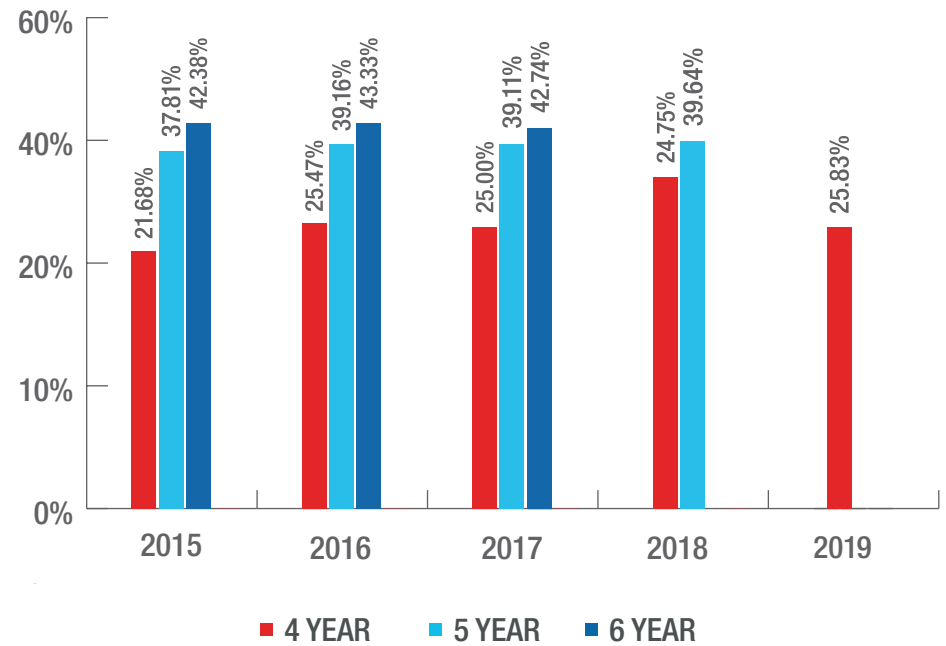

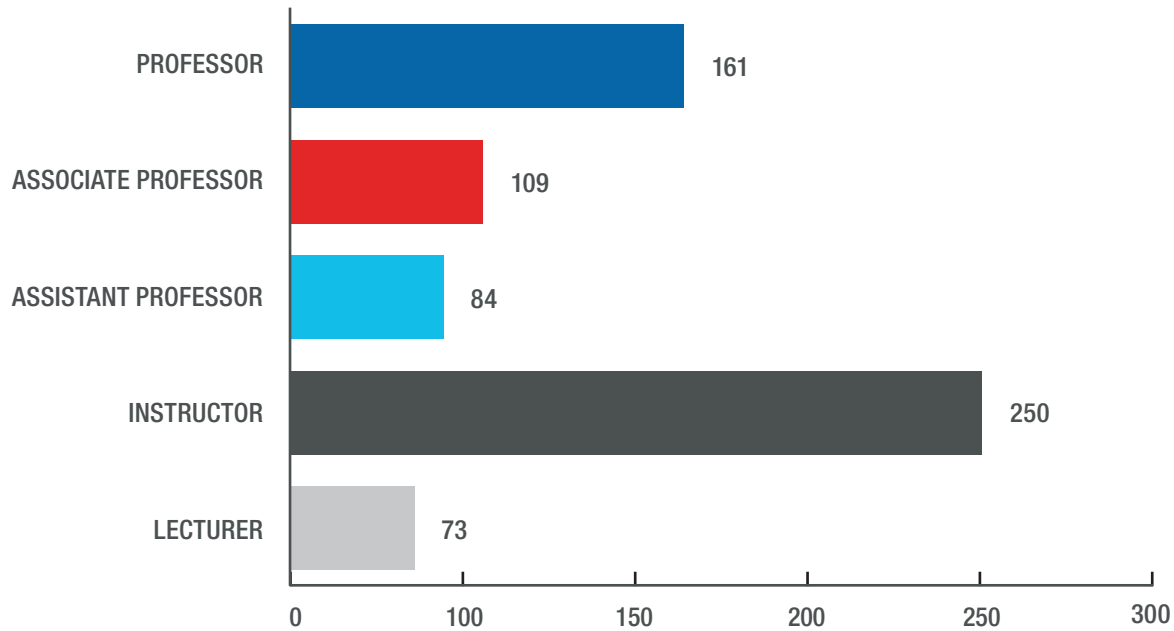

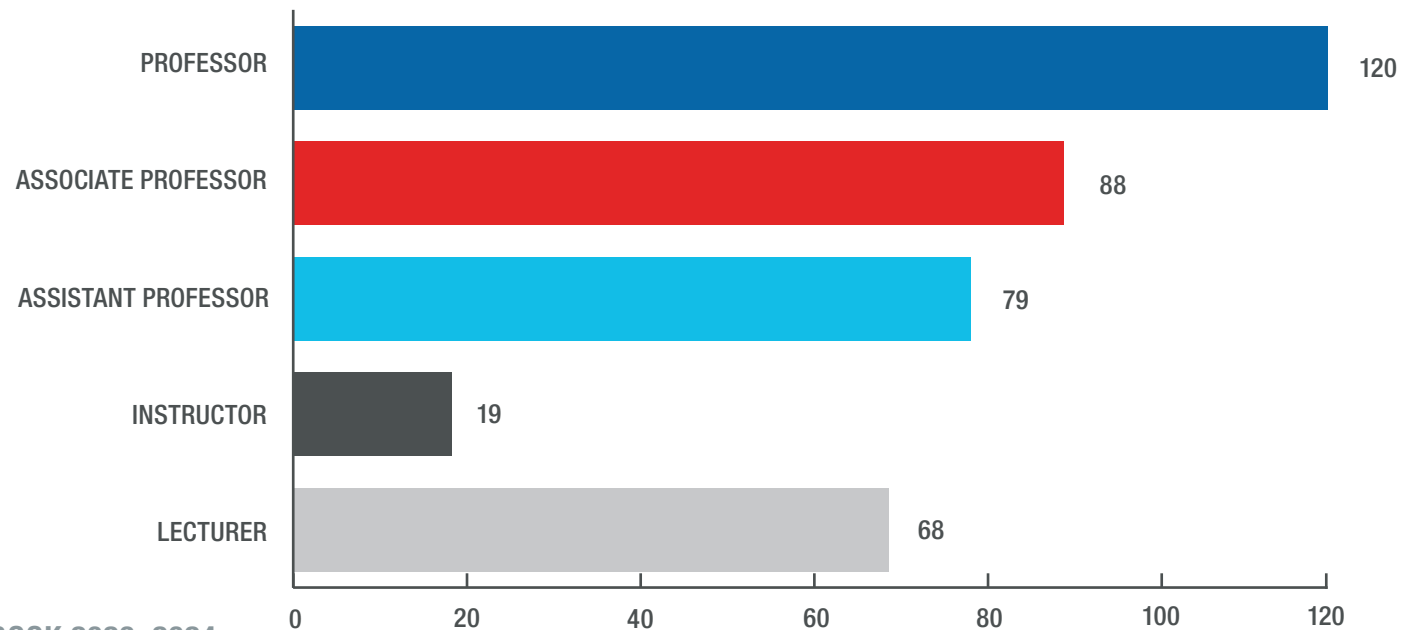

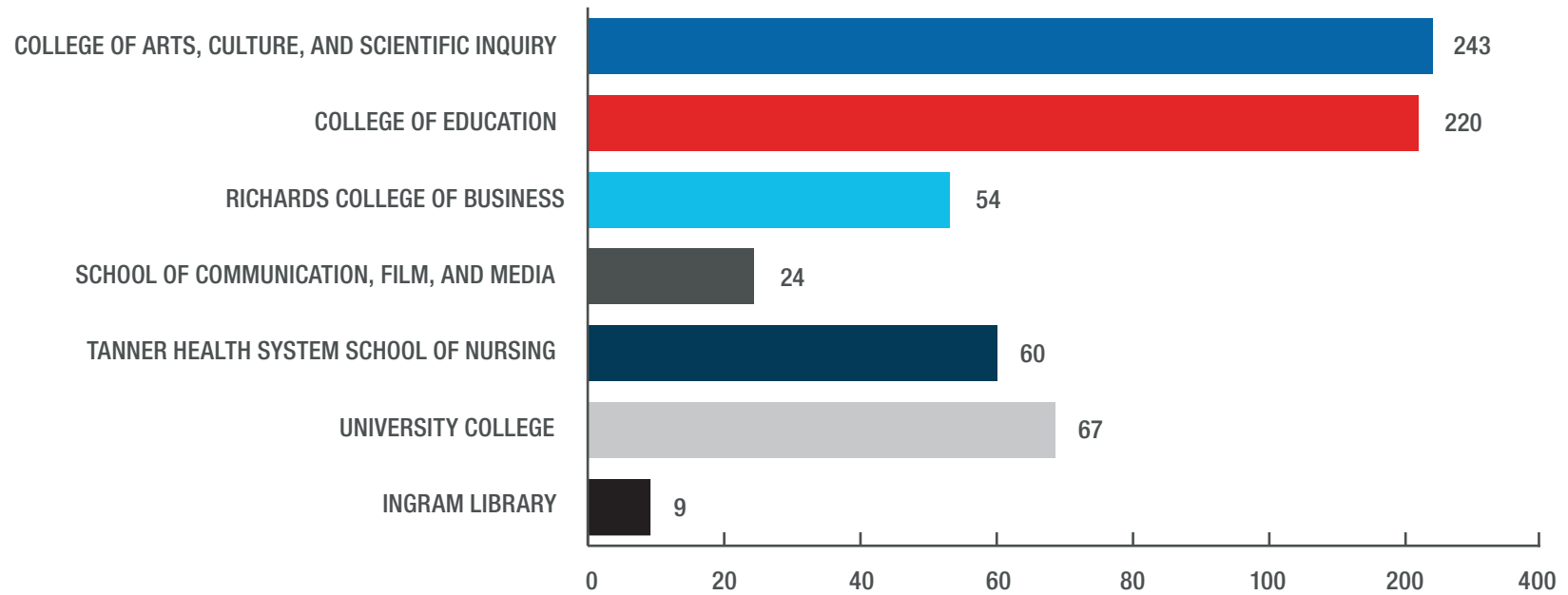
TOTAL FACULTY RANK FALL 2023



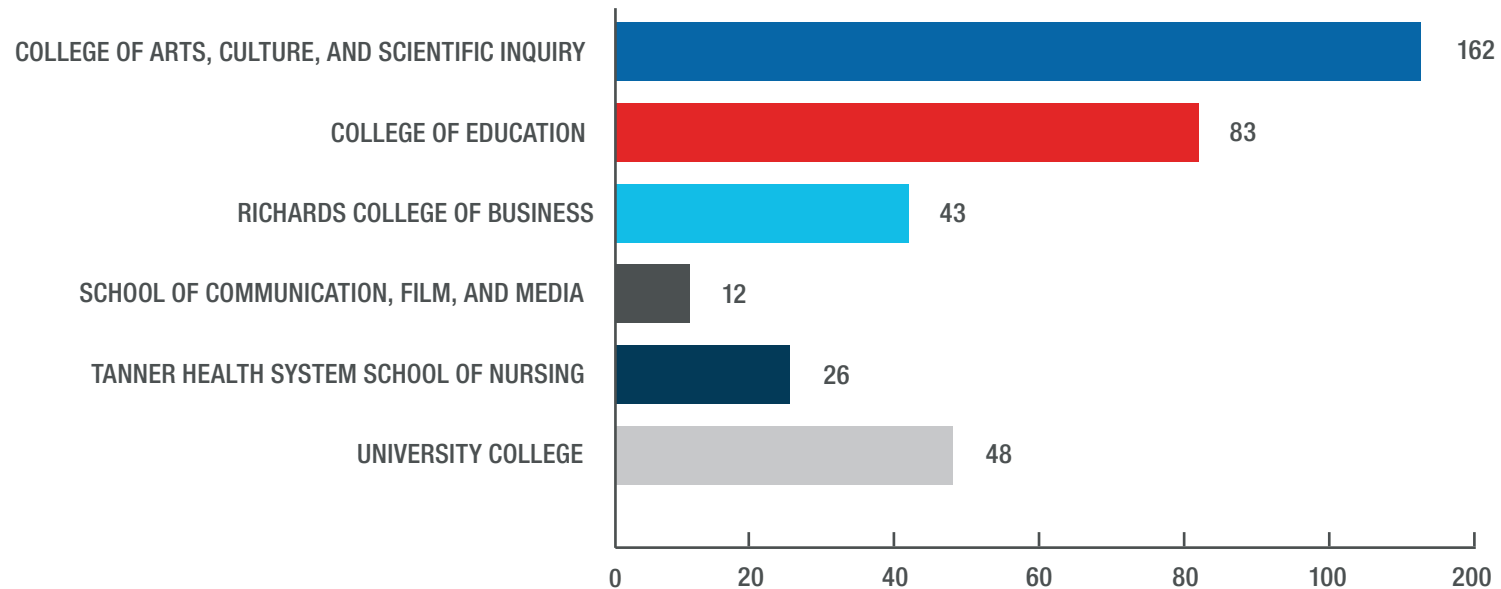
FULL-TIME FACULTY RANK FALL 2023



TOTAL FACULTY BY COLLEGE/SCHOOL/LIBRARY FALL 2023

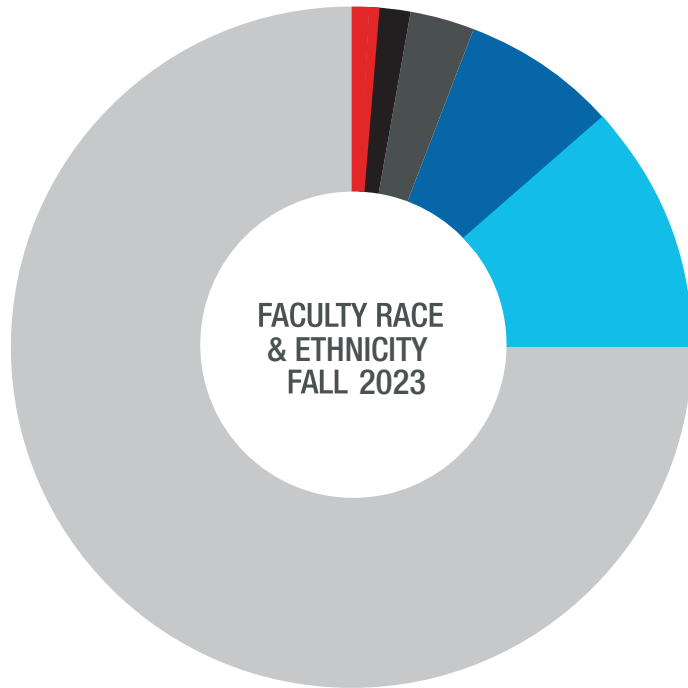


FULL-TIME FACULTY BY COLLEGE/SCHOOL FALL 2023

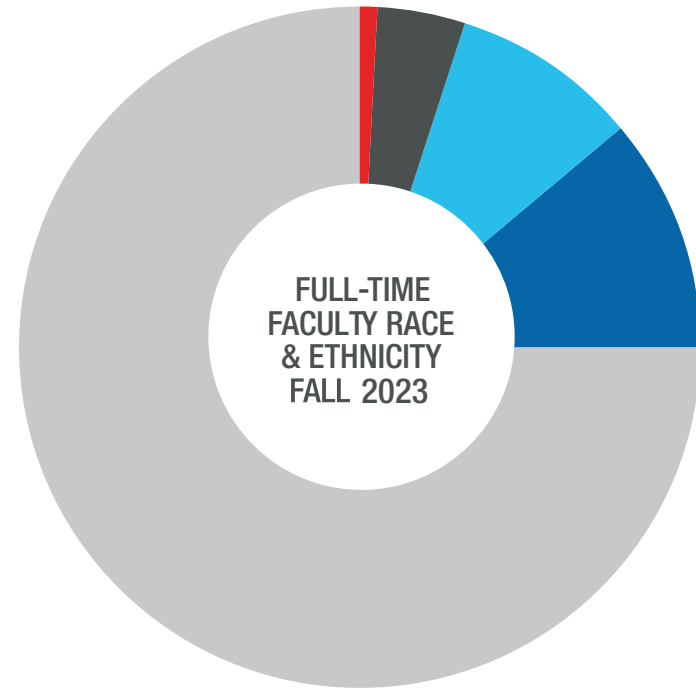

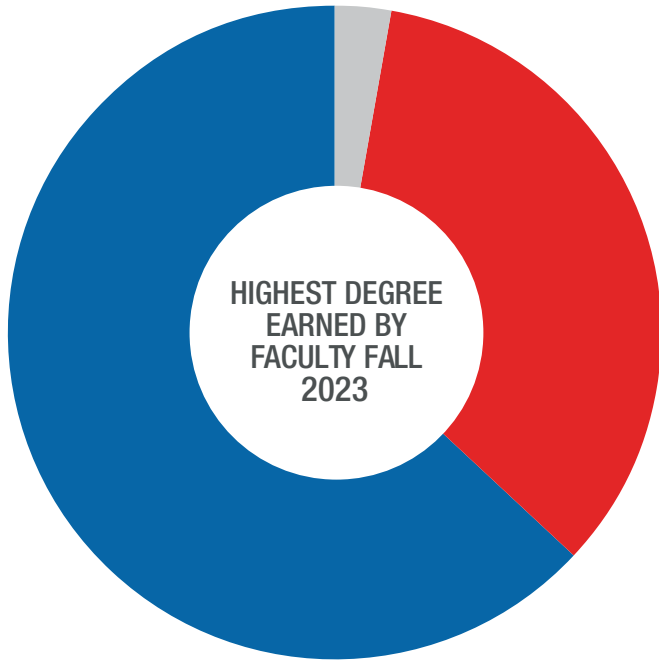

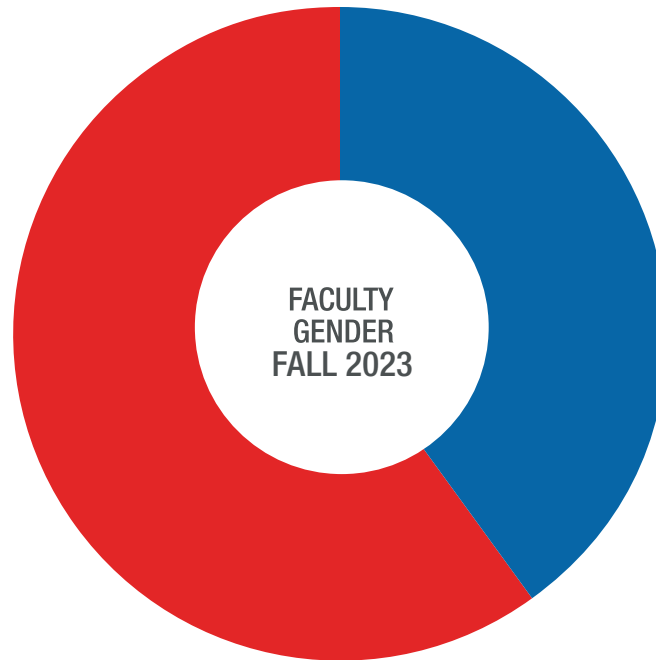

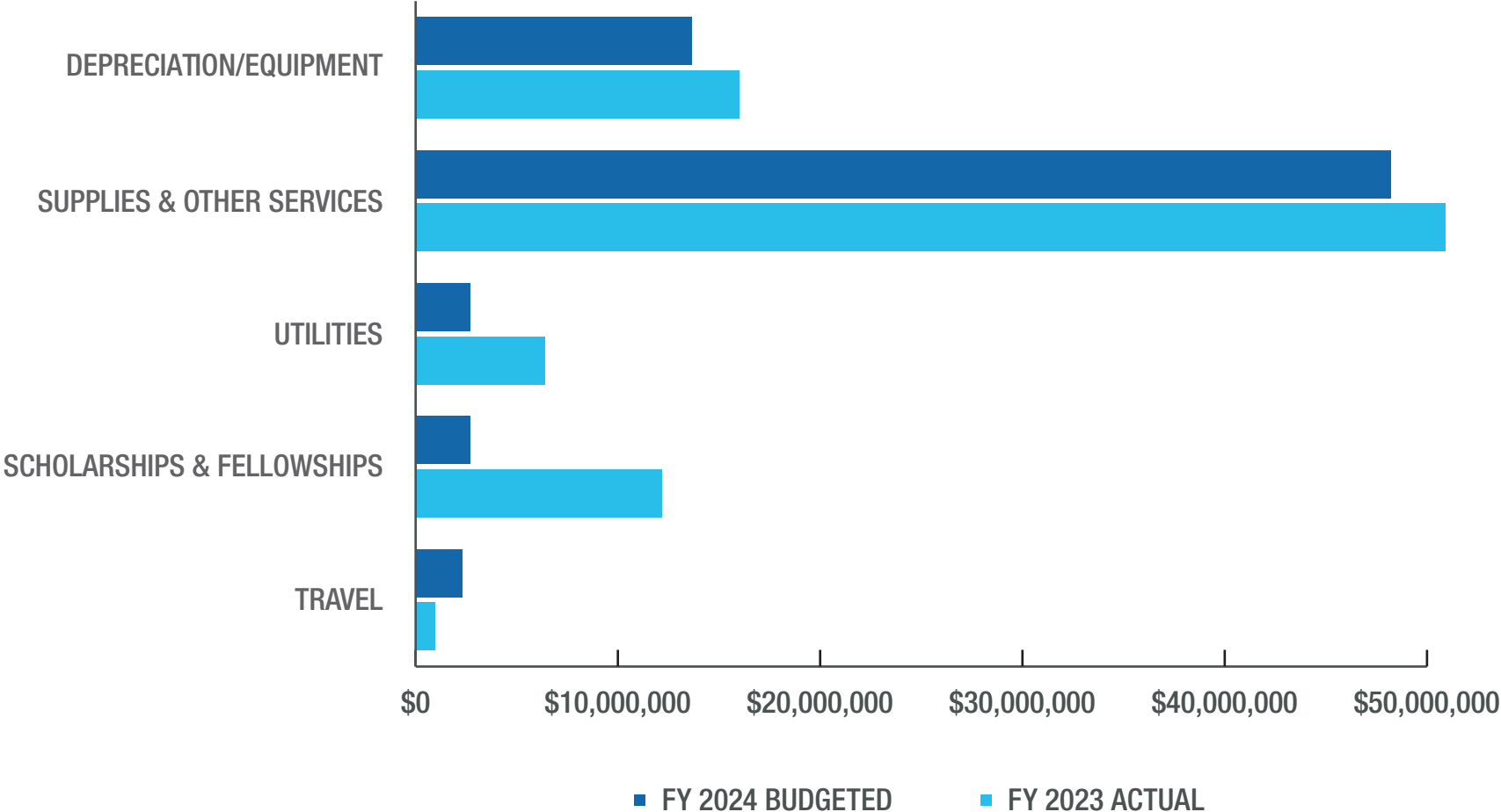

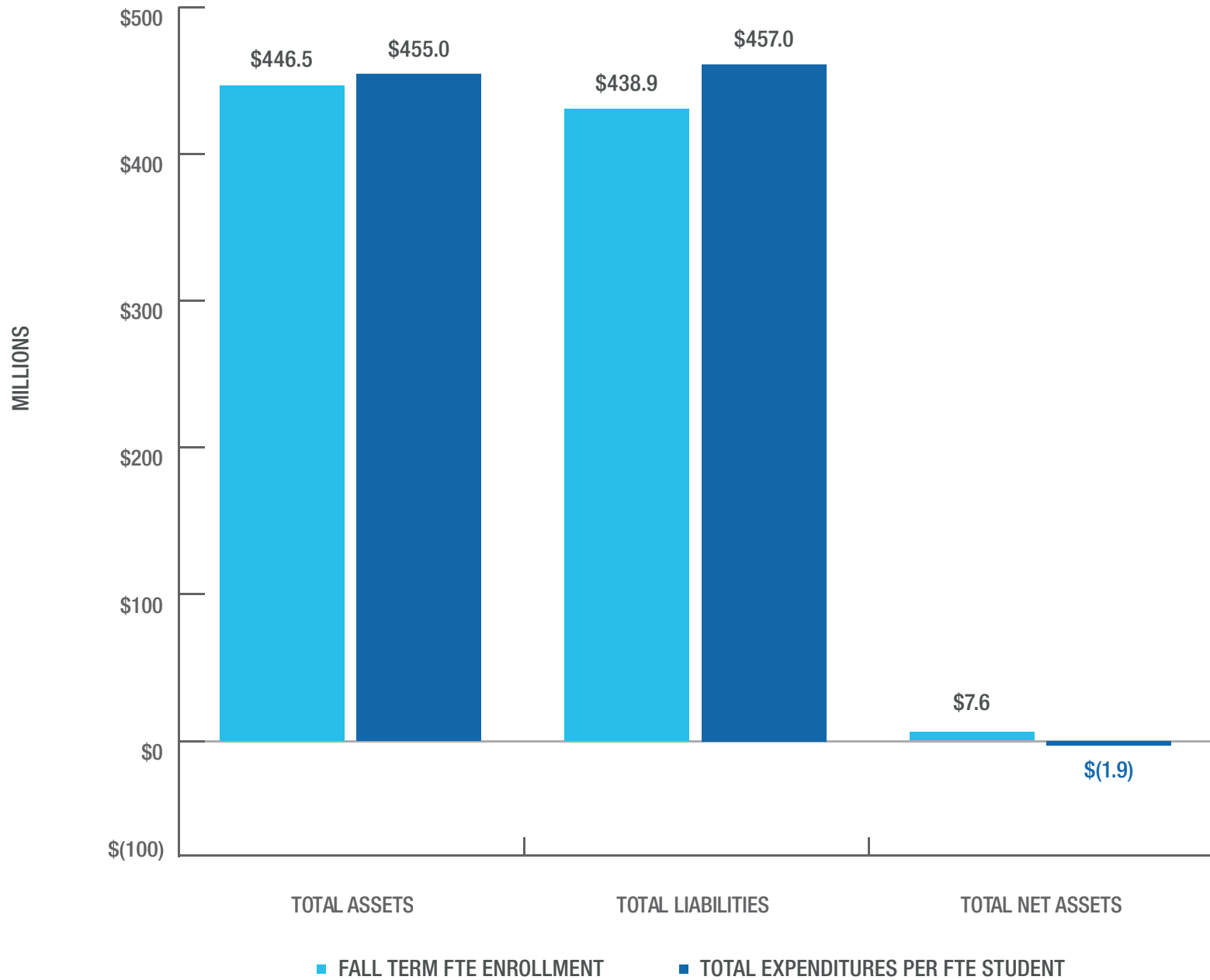

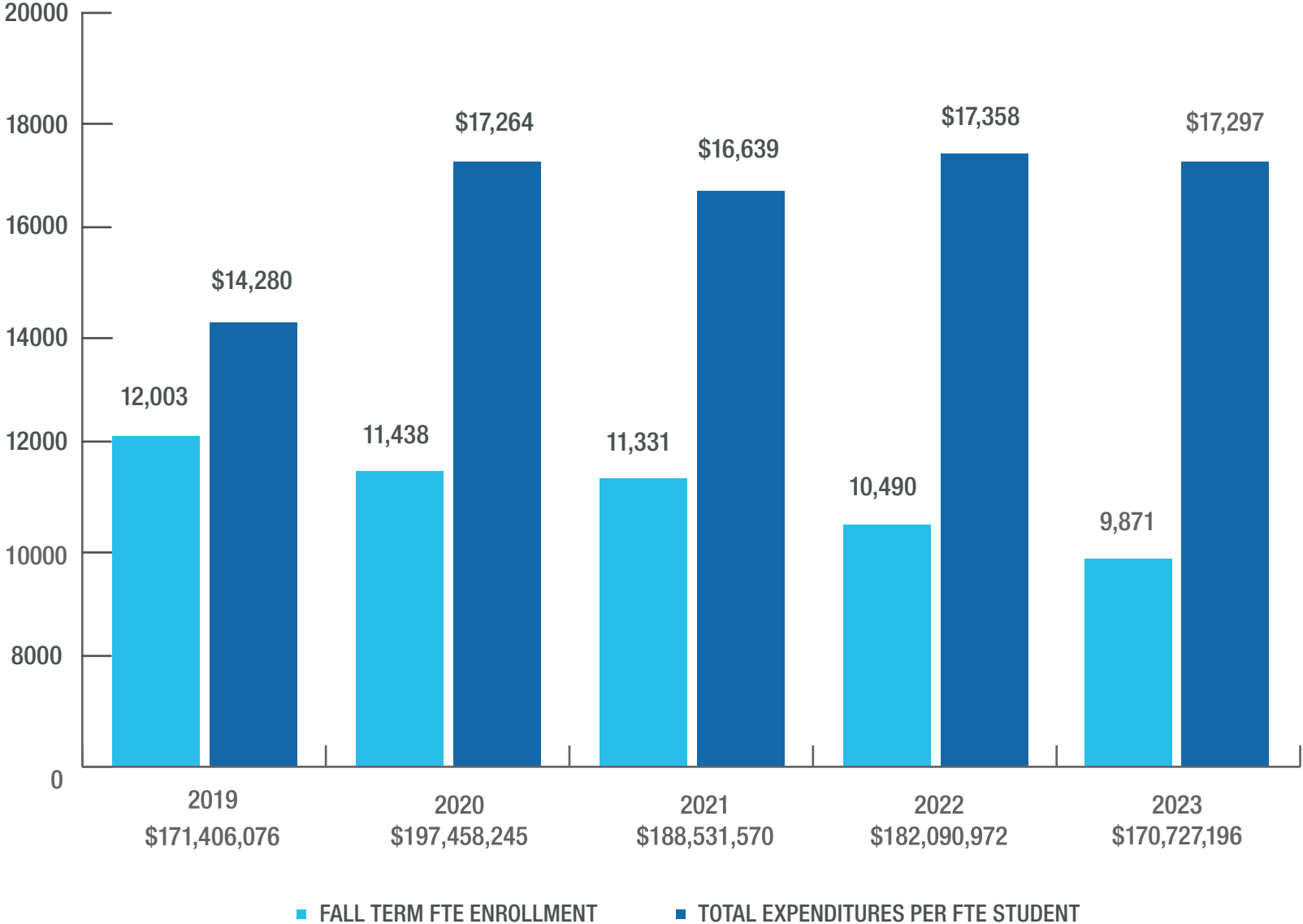
